IV. Treasurer's Report-Brian Lockard and Nancy Kilbride

- a) Checking and Money Market totals through March 2019 is \$23,190.33.
- b) Total membership is currently 177. (2017:199 members, 2016:193 members)
- c) Nancy reported that Harts Turkey Farm was finally straightened out and paid (from last Fall's Workshop)-\$1300 and Hats and lanyards cost is \$1671.50.

- c) Legislative / NH Public Health Association: The Board discussed HB475, establishing a shoreland septic system study commission. Comments or concerns should be emailed to the bills' sponsor.

a) Dennise distributed the current list of RSA's that reference HO's. Since Matt was not at this meeting, it was suggested to put this on the agenda for the next board meeting.

X. Hepatitis A discussion

a) Ren shared information that the State is hoping to set up vaccination clinics. Anyone should consider getting the vaccine, even HO's. Restaurants face the biggest challenges, especially smaller places. Ren shared talking points about Hep A that was developed by Nashua. We will ask Nancy to make several documents available on the NHHOA website, to include: Hep A Fact Sheet, Talking Points, and the contacts for the Public Health Networks.
